## 2014 CONFERENCE REPORT

### Report on the 37<sup>th</sup> Brain Impairment conference held in Fremantle, Western Australia, 8-10 May 2014.

This was the first ASSBI annual conference to be held in WA. Its theme was *Beyond the Hospital Door: The Longer Term Challenges of ABI*, and it proved a major success. Whilst principally offering an Australasian conference forum, participants also attended from Canada, Germany, Malaysia, New Zealand, Saudi Arabia, Singapore, Sweden, UK and USA. The total number of registrants was 322 with 85% being female, and 61% were first time ASSBI Conference attendees. In keeping with the theme of the conference, the long term impact of brain injury, the key note speakers focused in both their workshops and key note addresses on improving outcomes for individuals with brain injury in the months and years after they have been discharged from hospital. ASSBI was pleased to welcome two international speakers to Fremantle. Paediatric specialist Professor Keith Yeates from Ohio State University, provided insight into social outcomes for children with acquired brain injury. Professor Yeates took those in his workshop on a learning journey that considered social development outcomes for children with ABI through a model characterizing the relationship between social adjustment, relationships, problem solving, communication and cognitive processes. Associate Professor Jeff Kleim, Arizona State University, engaged the audiences with both his knowledge and visual images describing how neural plasticity supports learning in the intact brain and “relearning” in the damaged brain. His workshop focused on how functional outcomes can be enhanced by harnessing neural plasticity.

Australasian expertise was demonstrated both by local speakers and a newly constructed rehabilitation environment. Dr Kathryn McPherson, Professor of Rehabilitation at Auckland University of Technology, urged attendees to improve the effectiveness of rehabilitation through goal directed interdisciplinary processes that included the client, linked into therapy activities and could be generalised into the client’s life after discharge. Professor Beth Armstrong, Edith Cowan University, WA presented findings from her “Missing Voices” research examining communication difficulties after stroke and

traumatic brain injury in Indigenous Australians. Associate Professor Dianne Smith, Head of Interior Architecture at Curtin University, used the unique environment of the newly completed Oats St Rehabilitation Facility to assist workshop participants in exploring environmental influences on people with brain injury and encouraged them to consider how they would integrate elements of these influences into their workplaces.

Following a day of workshops, the conference was officially opened with a key note address from Western Australia’s recently retired Chief Scientist, Professor Lyn Beazley. Lyn delivered a highly entertaining and engaging address on the wonders of Western Australia, its biodiversity and the wide-ranging areas of scientific research that have drawn world-wide interest to the state. With her enormous enthusiasm for all things scientific and an extensive professional background in the field of neuro-regeneration Lyn was an ideal person to kick start the conference.

In their Keynote Addresses Professor Kleim spoke on teaching the new brain old tricks using neural plasticity, Professor Yeates discussed predicting outcomes in paediatric mild TBI, Professor Armstrong focussed on the communication difficulties for Indigenous Australians following stroke and TBI whilst Professor McPherson described a trial of goal setting in TBI. The Key Notes speakers were ably supported by ASSBI President, Professor David Shum, who delivered the Presidential address on his personal experiences and learnings in the development of neuropsychological measures

President Prof David Shum presented the student prizes to the undernoted:

Winner of the Kevin Walsh Award was Kim Mihaljevic with a highly commended prize going to Diane Randall

Winner of the Luria Award was Yvette Alway with a highly commended prize going to Elizabeth Beadle

Winner of the Travel Award was Wendy Longley

Two new awards were presented at the conference Kidsafe WA Award for best Paediatric Presentation was won by Ruth Tessellaar

The Mindlink Brightwater Interdisciplinary Focussed Research Award is an independent award first time presented by Mindlink Psychology and Brightwater Care Group to recognise and encourage innovative and interdisciplinary collaborative approaches for ABI clients and their support systems with capacity to carrying over into long term service delivery

Special mention: Andrea Aitchison for her presentation on The Evolution of a New Concussion Clinic and Evaluation of Efficacy and Client Perceptions

The winner of the Inaugural Award is: Claire Willis for her presentation: Bioto Stolen Healthsports Centre: Facilitating lifelong activity and participation

We received a large number of interesting Abstracts for the conference, and were able to put together a strong program of

papers and posters. The wide range of topics covered in the submissions allowed us to provide a program which ran with three parallel sessions throughout the conference.

Our thanks to the organising committee (Pascalle Bosboom, Peter Clissa, Mena Garcia-Vega, Anna Gubbay and Liz Vuletich), the Scientific Committee headed up by Jade Cartwright, Pascalle, Caroline Bulsara, Peter, Mena, Erin Godecke, Kristylee Sharp and Liz) and for the help of Doctoral Research students from the School of Psychology at UTAS. Thanks, too, to Margaret Eagers-Rickit, who as usual did a wonderful organisational job.

## WEBSITE

The focus for the website has been the extensive upgrade of all content, document ordering, the Amazon bookstore and the Conference for 2015. This has culminated in major changes to the menu system to cater for the different categories and content. There are now a total of 47 pages on the website including the document ordering system which was outsourced. The Conference pages were regularly updated throughout the year. The changeover to the updated website was in September – October.

When the website is revised for this year, we suggest that the members only content area is looked at as it has become somewhat dated.

Statistics for the website from 1-Jan 2014 until 31-Dec 2014 were as follows:

Number of unique visitors: 14,645

Number of visits: 24,690

Number of pages visited: 57,196

Number of hits: 888,326

Total bandwidth downloaded: 12.81 Gb

The peak month was October 2014 with the site receiving 116,267 hits and a download of 1.59 Gb

This coincided with the change to the updated and revised website.

The most popular pages ranked were the home page, 2015 Conference, privacy, workshops, ASSBI Products, Newsletter-Reports, membership, Invitation to 2015 Conference, webinars, and Access to Brain Impairment.

There were approx. 569,425 hits on the membership area for a total of 45,277 logins and a download of 8.42Gb, these statistics are separate from the overall website results.

Because of the complexity, the product ordering system was outsourced, credit card details are not kept on line. We keep no records of the activity which should be kept by ASSBI when orders are placed. Any charges will be integrated into the annual hosting fee.

The current web hosting arrangements are effective until July 2015.

The domain name [www.assbi.com.au](http://www.assbi.com.au) was renewed in September 2014, it is due again in September 2016. The domain name [www.assbi.com](http://www.assbi.com) was renewed in August 2014 and now due in August 2016 both are re-registered every 2 years.

Our ongoing commitments for ASSBI are maintaining the hosting of the domain names assbi.com and assbi.com.au and the domain forwarding, maintaining the domain name and registration of both domains.

## RESOURCES

In 2014 ASSBI had 11 resources (assessment and/or treatment) for sale and another 4 that were free to members.

**Communicate with Confidence** (\$95) is a practical guide for anyone wanting to improve or refresh their communications skills.

**Errorless learning in dementia: A practical manual** (\$38) is a manual that provides a step by step guide to the use of errorless learning techniques to re-establish everyday skills in people with dementia.

**Improving First Impressions** (\$140) is a manual that provides detailed program notes and handouts for 12 sessions that address training of basic areas of social skills.

**Making sense of brain tumour (MsoBT)** (\$100) is a manual that provides information and guidance for people living with brain tumours and their families.

**Making the most of your memory: An everyday memory program** (\$140) is a detailed manualised program for improving memory function with instructions for each session and a CD of PowerPoint slides for sessions and template handouts for printing.

**Managing social anxiety following traumatic brain injury (MSA)** (\$100) provides a structured therapeutic approach based on cognitive behavioural techniques to manage social anxiety in people with cognitive impairment.

**Memory Disorders: New types, assessment techniques and interventions** (\$110) this DVD provides an overview of some issues related to the assessment and remediation of memory disorders.

**Reading A Smile (and other great expressions): An Emotion Perception Kit** (\$340) is a comprehensive kit addressing remediation of emotion perception including 6 packs of photos, two game boards, flash cards, a manual and a DVD.

**TBI – Express: Social communication training for people with TBI and their communication partners** (\$160) is a treatment program for training people with TBI and their communication partners to improve everyday communication. This also comprises a manual and CD.

**Comprehensive Assessment of Prospective Memory (CAPM).** This manual provides a detailed approach to assessing prospective memory failure (i.e. failure to remember to do things at a later date) in clinical disorders.

**The Location Learning Test** (\$260) is a recently introduced test that assesses spatial memory

**Free Resources:** These include the **Austin Maze**, an electronic spatial learning test, the **Starship Post-traumatic Amnesia scale for children**, the **Symbol-Digit Modality test** and the **Westmead PTA Scale for children**.

## JOURNAL BRAIN IMPAIRMENT

### PUBLICATIONS COMMITTEE REPORT

Report put together by Jan Ewing Chair of the Publications Committee

Once again this has been a very successful year for the journal. I will summarise the main matters for consideration below but refer you to the Editors' report for more details regarding the journal's performance over the past twelve months:

1. Fifteen volumes (40 issues and 2 supplements) have been now published and the journal's reputation in the field continues to grow
2. Our ISI for 2014 is not yet available. The Impact Factor for 2013 of 0.878 represents a 35% increase from the previous year, although this reflects very small numbers and hence should be interpreted cautiously. The Scopus Journal Rank Index indicates relatively steady improvement in annual total citations from 2010 to 2013.
3. The transition to ScholarOne for electronic submissions and reviews was completed in August 2014 and is working well. This system will streamline the submission and review process and notably reduce the workload for the editors

4. Submissions almost doubled in 2011 and have remained relatively steady for the past three years (around 40-47) but there has been an increasing rate of rejection over that time (63% in 2014) reflecting the appropriately high standards set for publication acceptance. The number of published articles has remained steady since 2008 (19-23; 21 in 2014)
5. We anticipate publication of two regular issues (May, September) next year with a special issue in December
6. Our relationship with our publishers, Cambridge University Press has remained positive and supportive.
7. As noted in our last report, our founding co-editors, Jacinta Douglas and Robyn Tate, stepped down from their positions at the end of 2014. We re-iterate our enormous gratitude to them both for their extraordinary efforts in establishing the journal and bringing it to its currently very strong position that in a highly competitive field.
8. It is with great pleasure that the Publication Committee welcomes our new co-editors: Associate Professors Jennifer Fleming and Grahame Simpson. Both Jenny and Grahame step into this role from their former positions as associate editors of BI and hence they bring immediate knowledge of the operation of the journal as well as their extensive experience in other relevant publication roles
9. As part of this re-structure, it was agreed that four, rather than two, associate editors should be appointed, with efforts to optimise representation across relevant fields of interest and possible international presence. Jenny and Grahame will be involved in the process of appointing the four new associate editors as they become more familiar with their roles and the journal's best fit.
10. The re-structuring will also involve a review and refreshing of the Editorial Board over the coming months. We wish to acknowledge and thank the Board members for their support over the past twelve months
11. Finally, as always, the Publication Committee, on behalf of all ASSBI members, wishes to applaud and thank our entire editorial team for 2014, including our retiring co-editors, Robyn Tate and Jacinta Douglas and our former associate editors, now co-editors, Grahame Simpson and Jenny Fleming for their work over the past twelve months. As usual, they have produced a journal of which we are all very proud with unwavering professionalism and good humour.

### EDITORS REPORT

The following report provides an update on the progress of the journal over the last 12 months.

#### Completed Issues and content

Fifteen volumes (40 issues and 2 supplements) have been published. A general content summary is provided in Appendix B. In total we have published 247 papers, comprising the following:

- 193 original articles
- 22 literature reviews (including 11 systematic reviews)
- 4 brief reports
- 10 president's/invited addresses
- 11 Clinical Practice: Current Opinion articles

- 5 Controlled Trials Forum
- 2 case studies
- In total, there have been 11 Special Issues, covering the following topics: child neuropsychology (v.3.2), community rehabilitation (v.5.1), the ageing brain (v.5.2), neurogenic communication disorders (v.7.3), long-term care and support (v.8.3), stroke rehabilitation (v.9.2), prospective memory (v.10.1), outcome measurement for children and adolescents with brain impairment (v.11.2), growth through loss after brain injury (v.12.2), transition to community living after acquired brain injury (v.13.1) and state of the art reviews in mental health after traumatic brain injury (v.14.1).

**Number of submissions and editorial decisions**

The number of submissions received through to the end of 2014 and associated editorial decisions are shown in Table 1. Figure 1 shows the number of papers published throughout the life of the journal, which has remained steady since 2008, at around 20 articles.

Fig 1: Number of articles per year

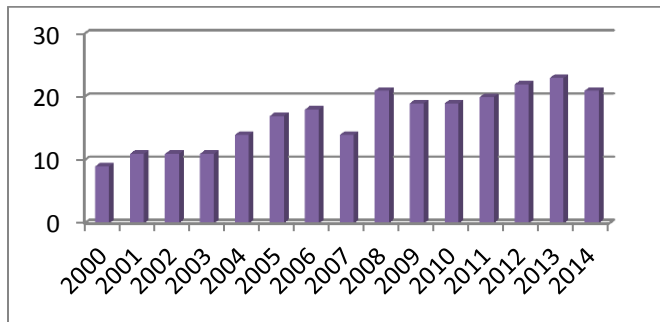

The increased rate of submission observed in 2012 has been maintained in 2013 and 2014. Similarly, the increased rate of rejection, at 60% and 63% in 2013 and 2014 respectively, noted since 2011 has also been maintained.

**Current Progress**

Inspection of Appendix B shows that although the number of published articles in 2014 (n=21) is similar to previous years (n=19-23 between 2008 to 2013), the number of journal pages in 2014 (n=230) was substantially fewer than in recent years (e.g., n=376 in 2012, n=480 in 2013). This is largely due to the cessation, commencing in 2014, of publishing the abstracts of two conferences, which was a regular feature of the journal for the previous 10 years. This therefore will enable a larger number of articles to be published in future issues without adding to the length of the journal, which will thereby provide opportunity for increased citations.

We have not as yet received the 2014 publisher’s report from Cambridge University Press (CUP). The Impact Factor for 2013 of 0.878 shows a 35% increase from the previous year (see Table 2). It is important recognise however, that we need to apply caution when interpreting change in the IF for *Brain Impairment* because the numbers involved at this stage are particularly small. In addition to the metrics included in Thomson ISI’s JCR, Scopus also provides journal metrics including a journal rank index normalised for different citation behaviour across subject areas (SJR) and annual total citations for a particular journal (included in Table 2). Although there is some variability in SJR, the annual total citations shows a promising trend with relatively steady improvement from 2010 to 2013.

**Move towards Electronic Submission**

As noted in previous annual reports, our move to CUP as publisher of *Brain Impairment* has enabled changing to the ScholarOne electronic submission system. The move to ScholarOne was completed on 1 August 2014. The transition was smooth and having ScholarOne will result in an enormous reduction of workload for the co-editors on a number of fronts:

- First, ScholarOne is a much more functional system than was the on-line submission process used with the previous publisher Australian Academic Press since 2012. The processing of manuscript submissions, reviewer reports, along with editor and author correspondence are efficient

and effective. By itself, however, the system will not necessarily result in a larger number of submissions – the increase in submissions was observed in the move from manual to the original on-line submission system 2012 (increase in submissions from 28 to 47 between 2011 and 2012; see Table 2). A fully functioning system of all aspects of handling the on-line submission process will reduce the frustrations of authors, reviewers and editors that occurred with the previous system.

- Second, ScholarOne brings with it the opportunity to run automated reports, which is a vast improvement on the system that operated for the first 15 years of journal publication, whereby data for each and every report had to be collected and collated by hand.
- Finally and importantly, an administrator, independent of the editors, has been appointed to enable administrative tasks for the journal submission process to be conducted, rather than the editors having to also assume the role of administrator.

### **Future Growth**

During 2014 the current Co-Editors made the difficult decision to stand down from co-editorship of *Brain Impairment*, positions we have held for the past 16 years. As such, this is our final annual report. As founding Co-Editors, it has been a challenging endeavour to first create and then develop a journal from inception; but also an endeavour that has had many rewards. In looking back over the years we are pleased that the journal has shown steady growth in the number of submissions and citations, along with an increased international profile. Our standards have meant that we always strived to publish only top quality articles and this stands the journal in good stead for its future. We know that we are leaving the journal in the excellent hands of our previous Associate Editors, who have stepped up to the Co-Editor positions. Following the appointment of the new Co-Editors, we ensured that there was a full and comprehensive handover of all procedures that we developed for *Brain Impairment* so that the transition to the new Co-Editors was seamless. It now leaves us to acknowledge the wonderful support we have had over many years from the Chair of the Publications Committee, Dr Jan Ewing, along with members of the Publications Committee; the dedication of our Associate Editors, Associate Professors Jennifer Fleming and Grahame Simpson; and the support from our publishers, first Australian Academic Press and more recently Cambridge University Press; the Executive of the Australasian Society for the Study of Brain Impairment; the Editorial Board members of *Brain Impairment*; and especially our journal reviewers and authors, without whom there would be no journal.

## **STUDENTS**

Nicci Grace from Melbourne is the student co-ordinator. Below is a report from Nicci:

The student ambassadors continued to promote ASSBI to various different university institutes, student networks and social media pages during 2014.

We had a successful student meeting at the annual conference in Perth, which was led by Dr Elizabeth Beadle. Following this meeting and feedback from students and ambassadors, a short survey was created regarding the structure of the student ambassador program, with a view to input these changes into a new model for 2015 and beyond. Based on all the feedback we received, a new model was proposed to the ASSBI executive regarding the restructuring of the 2015 Student Ambassador program. One of the main aims of the restructure is to facilitate a group effort amongst each state/city, with a feeling of community between the ambassadors themselves. This is a way to further facilitate networking between university students and research institutes, as well as providing incentive for students to become ambassadors. This will also naturally lead to a stronger community of connected students within the ASSBI community.

Students from all universities across Australia and disciplines (e.g., Speech Pathology, Clinical Psychology, Neuropsychology, OT) were encouraged to apply. The renewed role descriptions for 2015-2016 are as follows:

### **Team Leader**

There will be several 'Team Leaders' representing the major Australia cities. This role will be a two year commitment.

#### Position Description:

As team leader you will be responsible for liaising directly with ASSBI's student co-ordinator to update them on your team's progress. As team leader, you will be responsible for bringing together your team of student ambassadors from your city/state and running regular meetings (advised quarterly) where you plan as a group your proposed action to help promote ASSBI to your wider networks. It is expected that all team members, including the team leader, is responsible for this active promotion. This may be through a number of different mediums, such as presenting at conferences/seminars/lectures, distributing flyers to student communities and/or advertising on social media.

You will also be expected to organise with your team, at least one student ASSBI event per year (e.g., speaker, quiz night, pub night) where students are invited to attend and encouraged to participate and learn more about ASSBI. The student coordinator will be there to support you with providing ideas as to how best to run these types of events. As a team leader you will be responsible for liaising directly with ASSBI's student co-ordinator to update them on your team's progress.

**Student Ambassador**

There will be several Student Ambassador roles in each major Australian city. This role will be a one year commitment.

Position Description:

As a student ambassador you will work together with fellow student ambassadors who represent a range of disciplines (e.g psychology, speech pathology, occupational therapy, neuropsychology) to help promote ASSBI to your wider student communities and work towards generating a large student membership pool. This may be through a number of different mediums, such as presenting at conferences/seminars/lectures, distributing flyers to student communities and/or advertising on social media. You will also be expected to organise with your team, at least one student ASSBI event per year (e.g., speaker, quiz night, pub night) where students are invited to attend and encouraged to participate and learn more about ASSBI. It is expected that all student ambassadors work as a team under the guidance of their team leader and regularly feed-back their progress to them. Team leaders will be running quarterly team meetings which student ambassadors are expected to attend.

In November, a call-out was made to existing ambassadors to notify them of the changes and confirm if they wanted to continue in their roles. All existing ambassadors were given the opportunity to request the Team Leader position. Following this, advertising for new positions were made Australia wide, using the ASSBI executive’s connections, my own personal research into university course coordinators to approach across Australia, as well as a mail-out by media coordinator Rachael Rietdijk to several other university programs.

All applications were sent to myself and an attempt was made to ensure there was a representation from as many universities as possible and as many disciplines as possible. Positions are to be finalised in January 2015.

**1 Summary of Significant Accounting Policies**

**Basis of Preparation**

The director has prepared the financial statements on the basis that the company is a non reporting entity because there are no users dependent on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the needs of the business.
